# SCA Chinese Heritage Club Board of Directors Meeting January 18, 2011 Minutes

## Call to Order

- Food (Ta-tung): Catering Company now has necessary insurance which would cover SCA.
  Menu Dishes have been finalized. Snacks will be placed on dining tables. Table covering will be white; decorators can now choose their colors.
- Program (Kitty): Dress Rehearsals are scheduled.
  Approval of 2 dinner tickets to be awarded to the MCG group.
  Green Valley did not make a donation and M Resort and South Point will not send guests.

Morgan Shen's donations will be used for door prizes.

Good Will funds were approved for up to 14 invited guests.

- Table Seating (Celia & Lizwu): All members and guests are assigned seats: only waiting for the VIP list: there are 2 guest on waiting list.
- Channel 99 Interview: Ta-Tung will do the interview and Kitty will direct Channel 99 recording of the Spring Festival event.
